1. California Residents: Your California Privacy Rights

Residents of the State of California, under certain provisions of the California Civil Code, have the right to request from companies conducting business in California a list of all third parties to which the company has disclosed personally identifiable information during the preceding year for direct marketing purposes. Alternatively, the law provides that if the company has a Privacy Policy that gives either an opt-out or opt-in choice for use of your personally identifiable information by third parties (such as advertisers) for marketing purposes, the company may instead provide you with information on how to exercise your disclosure choice options.

Superior Psychiatric Services has opted for the alternative option and therefore presents this comprehensive Privacy Policy which provides you with details on how you may opt-out or optin to the use of your personally identifiable information by third parties for direct marketing purposes. Therefore, while Superior Psychiatric Services is not required to maintain or disclose a list of third parties that received your personally identifiable information for marketing purposes, general information concerning third-party Website advertisers is provided herein for your understanding.

2. Introduction

Superior Psychiatric Services is committed to safeguarding the privacy of its website visitors; this policy sets out how SPS will treat your personal information. Providing SPS with any personal information is not a requirement to access the SuperiorPsychiatric.com Website. SPS does not collect any personal information about you when you visit the SPS Website unless you choose to provide this information to us. SPS does, however, collect and store certain information automatically. SPS handles information about your visit to its website as detailed herein.

SuperiorPsychiatric.com collects information for Website management and statistical purposes. SPS uses the collected information for statistical and demographic purposes, i.e.: to count the number of visitors to each unique SPS Website or page, to establish the type of visitors, to list the most visited content, etc., all of these to improve and make the SPS Websites more useful to visitors like you.

This SPS Website receives and stores any information you enter on the SPS Website or give SuperiorPsychiatric.com in any other way, such as via telephone, electronic mail, online or otherwise. For example, this information may be collected when you send a request using the "Contact Us" page or form, when registering to comment on one or more of the Blog entries, or when you contact Superior Psychiatric Services for customer, not medical, support. - d. Security measures designed to protect the loss or misuse of information under the control of SuperiorPsychiatric.com; and
- e. How to maintain the accuracy of your information.

3. Superior Psychiatric Services' Blog Disclaimer

Certain features of the SPS Website may allow you to contribute content. By their very nature, this information may reveal your identity or be linked to you personally. The SPS Website may make blogs, message boards and other public forums available to its users. If you post personal information online, it will be publicly available and this information may reveal your identity or be linked to you personally. You may, therefore, receive unsolicited messages from other parties. SPS cannot ensure the security of any information you choose to make public, nor can SPS ensure that parties who have access to such publicly available information will respect your privacy. Please exercise caution when deciding to disclose personal information in these areas.

Any information you may disclose in any User Directory, case studies, testimonials, Forums, or other public areas of the SPS Web sites, or anywhere on the Internet, becomes public information. You must exercise caution when deciding to disclose personal information in any public area. Please know that if you submit comments, blog entries or other user-generated content to the SPS Website, it may be published online or offline in any media or format, whether currently existing or hereafter developed. Others may have access to this content and may have the ability to share it with third parties across the Internet. SPS may also publish your name, email or other personal information with the content or a portion thereof. SPS may also use the content or a portion thereof for advertising, marketing, publicity and promotional activities.

Due to the extent of the variables identified within this Section 3, this SPS Privacy Policy does not apply to any information you freely supply on any SPS Message Board, including comments posted to Blog entries. Please be judicious in providing personal or sensitive information. While Message Board/BLOG moderators will do their best to identify and exclude other participants who are collecting information for purposes other than merely commenting on SPS BLOG posts, no SPS moderator can be responsible for information gathered by other participants.

4. <u>Registration and Account Information</u>

Visitors to the SPS Website are not required to register in any manner. Users are asked to provide certain personal information when they submit a request through a "Contact Us" form or attempt to post a comment to any of the Blog entries. This information may include, but may not be limited to, name, address, telephone number, email address, and other information, perhaps such as the type of personal computer being used to access the Website. Users may be asked to complete an online form that collects information about demographics, product or website usage and preferences, along with other information that will help SPS improve its Website. SPS through its Website may collect and store anonymous demographic information

(such as your zip code, gender and age), and use this data to tailor your experience at our Site, provide content that SPS may determine you might be interested in, perform general improvements to the Site, and display the content according to your preferences. SPS may also generate non-identifying and aggregate profiles from personal information Users provide during registration (such as the total number, but not the names, of Users). As explained in more detail below, SPS may in certain instances use this aggregated and non-identifying information to sell advertisements that may appear on the website.

SuperiorPsychiatric.com may, though does not at this current time, collect and may retain certain financial information from you during an account registration process, or in connection with other SPS' products and services offered on the SPS Website. SPS will never sell, share or rent any financial information collected from you except as disclosed in this policy or as necessary to fulfill your order

5. Superior Psychiatric Services Partners and Sponsors

Some products and services are offered to Visitors and Users in conjunction with a partner (e.g., for joint promotions, as described in paragraph 3 above). To provide Visitors and Users with some of these products and services, the partner may need to collect and maintain personal information. In these instances, SPS will provide such data collected or transferred to our Partners and Sponsors. Additionally, there may be an opportunity for SPS Users to have cobranded pages that are co-sponsored by non-affiliated partners [though this is not in use at the time this Policy was enacted]. If or when partners or sponsors exist, SPS will share non-identifying and aggregate information (except as described above), but not personally identifiable information of individual Users, with such partners in order to administer the cobranded products or services offered.

6. Online Shopping

At some web pages that you access through links on the SPS Website, you may be able to purchase products and services or register to receive materials, such as a catalog or new product updates. In many cases, you may be asked to provide contact information, such as your name, address, e-mail address, phone number, and credit/debit card information. If you complete an order for any product or service that is not provided by SPS, SPS has no control over the third parties' use of any personal information you provide when placing such an order and therefore SPS has no responsibility or liability for the manner in which the organizations that operate such linked websites may collect, use or disclose, secure and otherwise treat your personal information to these third parties without your express written consent. SPS may provide links to these web sites as a convenience to the User. Please exercise care when visiting linked web sites. The linked web sites have separate and independent privacy statements, notices and

terms of use which SPS recommends you read carefully. At the time SPS enacted this Policy, you are not able to order any products directly from SPS. If in the future you the ability to order products directly from SPS is enacted, then SPS will use the personal information you provide only to process that order. SPS will not and does not share this information with outside parties except to the extent necessary to complete that order.

7. Online Advertisements

Superior Psychiatric Services does not share personally identifiable information about its individual Visitors or Users with advertisers. SPS may display online advertisements and may share aggregated and non-identifying information about its Visitors and Users collected through the 'Contact Us' or Blog-comment registration process, as well as through online surveys and promotions with these advertisers. Additionally, in some instances, SPS uses this aggregated and non-identifying information to deliver tailored advertisements. 8. <u>What Information does Superior Psychiatric Services' Website collect?</u>

If you do nothing during your visit but browse through the SPS website, read pages, or download information, the SuperiorPsychiatric.com Website will gather and store certain information about your visit automatically. This information does not identify you personally. SPS automatically collects and stores only the following information about your visit:

- The Internet domain of your Internet Service Provider (ISP) or institution you use to connect and access the SPS Website (company.com, institution.org, school.edu, etc.);
- Your IP address, which is a number that is automatically assigned to your computer whenever you are connected to the Internet;
- The type of browser and operating system used to access our site;

For other uses, the SuperiorPsychiatric.com Website may collect, store and use the following kinds of personal data:

- b. Information relating to any transactions carried out between you and SuperiorPsychiatric.com on or in relation to these websites, including information relating to any purchases you make of SPS goods or services;
- c. Information that you provide to SuperiorPsychiatric.com for the purpose of registering with the SPS Website, primarily including your user registration necessary for posting comments on the SuperiorPsychiatric.com BLOG or as entered in any "Contact Us" page or form;

The SuperiorPsychiatric.com Website uses embedded scripts. SPS may use this information for a number of purposes including, for example, to enhance or customize content served to users of the SPS Website.

Author Information: Some articles may be published on the SuperiorPsychiatric.com Website from time to time and these may include personally identifying information about its author(s). This information is used solely to provide website users with a means to contact the author and also provide link-backs to the author(s) preferred web page. Authors who seek to have their articles published here are required to provide contact information.

9. Cookies, Web Beacons, and Similar Technologies

A cookie consists of information sent by a web server to a web browser, and stored by the browser. The information is then sent back to the server each time the browser requests a page from the server. This enables the web server to identify and track the web browser. Cookies help create a speedy web experience by remembering your address and email information, so you don't have to re-type it when making multiple purchases. They also enable you to recall previous purchases.

Cookies do not store credit card information.

SuperiorPsychiatric.com may use cookies, web beacons, or similar technologies in combination with your SPS information to enhance and personalize your experience on the SuperiorPsychiatric.com Website. SPS may use both "session" cookies and "persistent" cookies on these websites. SPS will use the session cookies to keep track of you while you navigate the website and to determine generic interest and popularity among various documents and/or posts. SPS will use the persistent cookies to enable the SPS website to recognize you when you visit. Session cookies will be deleted from your computer when you close your browser. Persistent cookies will remain stored on your computer until deleted, or until a specified expiration date.

SuperiorPsychiatric.com and its advertisers may also use ad network providers to help present advertisements on the SPS Website. These ad network providers use cookies, web beacons, or similar technologies on your computer to help present, better target, and measure the effectiveness of their advertisements, using data gathered over time and across their networks of sites to determine or predict the characteristics and preferences of their audience. SPS may share certain non-personally identifiable information about you as a user (such as user IP address and its related zip code) with certain ad network providers to help them deliver more relevant advertisements through their ad networks. You can control cookies through your browser's settings. Most browsers allow you to reject all cookies, while some browsers allow you to reject just third party cookies. For example, in Internet Explorer you can refuse all cookies by clicking "Tools", "Internet Options," "Privacy," and selecting "Block all cookies" using the sliding selector. Blocking all cookies will, however, have a negative impact upon the usability of many websites, including some portions of this SPS

Website. If you reject all cookies, you may not be able to take advantage of certain SuperiorPsychiatric.com offerings.

SuperiorPsychiatric.com advertisers and/or its payment services providers [if or when such function may be implemented] may also send you cookies.

SuperiorPsychiatric.com may also use clear GIFs, or pixel tags, provided by third-party adserving companies to help manage its online advertising. These clear GIFs allow those adserving companies used by SPS to recognize a browser's cookie when a browser visits the SPS Website. This allows SPS to learn which banner or other promotional ads bring users from the SPS Website to a particular advertiser. The information SPS collects and shares through this technology is not personally identifiable (it does not include your name, address, telephone number or e-mail address).

Google Adsense and the DoubleClick DART Cookie.

Google, as a third party advertisement vendor, uses cookies to serve ads on the SPS Website. The use of DART cookies by Google enables them to serve adverts to visitors that are based on their visits to this website as well as other sites on the internet.

10. <u>Your E-Mail</u>

<u>If You Send Superior Psychiatric Services E-Mail</u>: You may choose to provide SPS with personal information, as in e-Mail with a comment or question. SPS uses the information to improve its services to you or to respond to your request.

<u>Responses to E-Mail Inquiries</u>: When Visitors or Users send e-mail inquiries to SPS, the return e-mail address (and other personal information provided in the inquiry) is used to answer the e-mail inquiry received. SPS does not use the return e-mail address for any other purpose and does not share the return e-mail address with any third party.

Unless you consent, SPS will not use your personal information for any purpose other than that for which it is submitted. SPS uses personal information to reply to inquiries, handle complaints, provide operational notices and in program record-keeping.

Except for authorized law enforcement investigations, SPS will never share e-mail information with any other outside organizations.

11. Using Your Personal Data

Personal data submitted on the SuperiorPsychiatric.com Website will be used for the purposes specified in this Privacy Policy or in relevant parts of the website.

SuperiorPsychiatric.com may use your personal information to:

- a. Administer the website;
- b. Improve your browsing experience by personalizing the website;
- c. Enable your use of the services available on the website;
- d. Send to you goods purchased via the website, and supply to you services purchased via the website;
- e. Send statements and invoices to you, and collect payments from you;
- f. Send you general (non-marketing) commercial communications;
- g. Send you email notifications which you have specifically requested;
- h. Send to you a Superior Psychiatric Services' newsletter, if or when such publication is made available, and other marketing communications relating to SPS business or the businesses of carefully-selected third parties which SPS believes may be of interest to you by post or, where you have specifically agreed to this, by email or similar technology (you can inform us at any time if you no longer require marketing communications);
- i. Provide third parties with statistical information about SPS users but this information will not be used to identify any individual user; and
- j. Deal with inquiries and complaints made by or about you relating to the website.

Where you submit personal information for publication on the SuperiorPsychiatric.com Website, SPS will publish and otherwise use that information in accordance with the license you grant to SPS.

SPS will not, without your express written consent, provide your personal information to any third parties for the purpose of direct marketing.

Currently, the SuperiorPsychiatric.com Website does not accept payments for services nor acts as a conduit of payment information to any of the SPS advertisers. There may be a time in the future when SuperiorPsychiatric.com may allow financial transactions between SPS and its patients. If or when that time comes, all SuperiorPsychiatric.com Website financial transactions will be handled either through SPS directly or through a payment services provider, such as PayPal. If the time comes when this SPS website accepts such payments, you should only provide your personal information to whichever payment processor SPS chooses to use after reviewing the payment processor's privacy policy. 12. Disclosures

SuperiorPsychiatric.com may disclose information about you to any of SPS employees, officers, agents, suppliers or subcontractors insofar as reasonably necessary for the purposes as set out in this privacy policy.

In addition, SPS may disclose information about you:

- a. To the extent that SPS is required to do so to comply with any valid legal process such as a search warrant, subpoena, statute or court order;
- b. In connection with any legal proceedings or prospective legal proceedings;
- c. In order to establish, exercise or defend the legal rights of SPS (including providing information to others for the purposes of fraud prevention and reducing credit risk); and
- d. To the purchaser (or prospective purchaser) of any business or asset which SPS is (or may be contemplating) selling.

Further, personally identifying and entity identifying information may be disclosed to third parties in an effort to protect the rights of authorship or other proprietary rights, including rights arising under the Copyright Act. This may include, but is not limited to, any of the following:

- a. Filing a complaint and other pleadings in a U.S. District Court or other court of proper jurisdiction in a suit alleging copyright infringement and other claims;
- b. Filing a petition with the Copyright Office for revocation of a registration of a copyright, in the case of a registration of a work that constitutes or contains a work of authorship; and/or
- c. Filing a complaint with an ethics panel of a state medical board, an Inspector General or professional conduct office of a federal agency, or a Dean or academic integrity panel of a medical school or university.
- d. Information concerning persons known to infringe on the intellectual property rights of others or make false claims of authorship may be shared with other electronic publishers.

SuperiorPsychiatric.com does not currently do this, nor are their plans to do so in the future. This may, however, be done at some time in the future, for the purpose of limiting loses due to infringement and other misuse of electronic products.

Except as provided in this privacy policy, SPS will not provide your information to third parties.

13. FTC Endorsement Compliance and Requisite Disclosure

Superior Psychiatric Services intends to treat its customers fairly and to comply fully with all Federal Trade Commissions (FTC) regulations related to advertising. This includes, but is not limited to, Federal Trade Commission 16 CFR Part 255: Guides Concerning the Use of Endorsements and Testimonials in Advertising, which requires, among other criteria, the disclosure of material connections between advertisers and endorsers. This includes directories, review/rating sites, blogs and other websites, email or collateral that purport to provide an endorsement or assessment of an advertiser, which SPS must prominently disclose the fact that financial or in-kind compensation is provided from the advertiser. 14. Voluntary Customer Surveys

Unless otherwise noted in the survey invitation or the survey itself, Users have the option of completing surveys anonymously or providing SPS with contact information. If provided, SPS may use the contact information to follow up with Users based on the answers they provide. SPS may also contact you to highlight any changes made in response to feedback.

15. Service Providers

SuperiorPsychiatric.com may transfer (or otherwise make available) your personal information to SPS affiliates and other third parties who provide services on its behalf. For example, as discussed above, SPS may use service providers to authorize and process payments, administer surveys, and run various promotions. Your personal information may be maintained and processed by these affiliates and other third party service providers in the US or other jurisdictions. SPS service providers receive information they need to perform their designated functions, and SPS does not authorize its affiliates or third parties to use or disclose personal information for their own marketing or other purposes.

16. Sale of Business

Superior Psychiatric Services may transfer your personal information as an asset in connection with a merger or sale (including transfers made as part of insolvency or bankruptcy proceedings) involving all or part of SPS as part of a corporate reorganization or stock sale or other change in corporate control.

In the event that ownership of SuperiorPsychiatric.com was to change as a result of a merger, acquisition or transfer to another company or clinic, your SPS Information may be transferred. If such a transfer results in a material change in the use of your SPS information, SPS will provide notice about the choices you have to decline to permit such a transfer of information.

17. Exceptions
